

Please note that I will need the wavier on the last page signed and sent to me either electronically, mailed or given the morning of the trial.

If you are ill, please stay home. Make sure your dog is ok with people wearing masks. We don't want a dog becoming fearful due to something they've never seen before.

MASKS: Masks will NOT be required while at the show. You are welcome to still wear them, and ask exhibitors to respect distance of others, but they will not be required. Exhibitors who will be wearing masks will need to dispose of single use masks properly.

FOOD: We will NOT be serving food but will be doing ice cream for workers for the last class each day! Please bring your own cold lunch or there are several fast-food restaurants nearby in Romeo. The gas station at 32 and Rochester Rd has a Subway along with plenty of drinks if you run out.

CRATING & SPECTATING: All four sides of the ring will be available for tent set up along with the previously available space. Please be mindful of any blocked off areas (this is our home and the orchard is still a working orchard – may have recently been sprayed, so please stay out). Be considerate of how you park and don't run your car when not driving to prevent exhaust from entering another car - Bring a shade tent or screens if you'll be crating out of your car or near your car - Stock up on batteries for crate fans.

DAY OF SHOW ENTRIES: We are still planning on taking DOS entries at this time. I am encouraging exhibitors to e-mail me their entry the night before but will still be taking them morning of.

COURSE MAPS: Will be emailed in pdf format to you the evening before each trial day, usually by 7 pm of the time zone you are in. Full size courses will be posted at the site as well. If you do not receive a map by 7 pm the night before please let me know but I will have a few printed copies available at the show for DOS, people traveling, etc.

GENERAL BRIEFING: Will be sent out in the final briefing. The general briefing will also be posted at the site.

JUDGES' CLASS BRIEFINGS: Will be listed on each course map. The judge may do briefings for specific classes that may have more questions from exhibitors such as Jackpot.

WORKER SIGN UP: We have a worker sign-up sheet available online at https://docs.google.com/spreadsheets/d/11_pSUE_n_khENfdapEpe-bqj82DmnP3mP2mLDMVrb5Gs/edit#gid=8272464. Please remember what classes and levels you sign up for! We will post the sheet for reference as well. Workers will receive coupons for working, or they can submit their coupon(s) in a raffle for \$50 SCCA agility trial coupon pulled on Sunday! This will be mailed if you are not present.

COURSE BUILDERS & RING CREW: Please wash your hands before and after working. We usually have a great group of people that course build!

RUNNING ORDERS: Pre-entered running orders will be posted on our site AFTER July 26th at <http://www.stonycreekcanineacademy.com/cpe-competitor-page.html>. Scroll to the bottom of the page. A main exhibitor running order will be available to view at the show after DOS's have been entered.

AT THE GATE BEFORE A RUN: This will be the exhibitor's responsibility to physical distance and be ready to run when it is your turn. We are also asking that people please do not sit at the judge/secretary table inside the ring while waiting their turn to run.

LEASHES: Dogs must still run naked. All handlers have the choice to put their leash in their pocket or safely loop it around their waist or neck, it does not have to be out of the dog's sight, however, if the dog plays with it during the run, it would be considered a toy. If the handler cannot carry their leash, leashes will be dropped on the ground at the start line and the leash runner will pick it up and place it at the exit gate on a chair or the ground/floor. Do not loop leashes on the ring barrier.

RESULTS: Results will be posted at the trial for review in the Salesroom. **Dogs will NOT be permitted in the Salesroom for this trial.** The orchard will be opening for the season soon.

RIBBONS: We will have ribbons available in our apple orchard Salesroom (large white building where results will be posted as well). If you are not going to keep the ribbons, please do not take any – ribbons cannot be recycled at this time.

SCENT TRIAL: We will also be holding a Canine Scent Sport on Saturday and Sunday starting around 1pm. The Agility trial will take priority over the Scent trial. You will not miss your runs in either trial.
